## ABOUT THE KENTUCKY ASSOCIATION OF COUNTIES

The KACo insurance programs include the KACo Workers'



Compensation Fund formed in 1978, and the KACo All Lines Fund (KALF) formed in 1987, which offers property and liability lines of coverage. Liability lines Include general liability, law enforcement, employment, public officials, auto, cyber and crime. The funds are structured as independent Group Self-Insurance pools

under Kentucky law (KRS 304.48 and 304.50). Each is governed by a 5-member Board of Directors comprised of participating elected officials appointed by the Board of Directors of the Kentucky Association of Counties and regulated by the Kentucky Department of Insurance.

#### Structure and Staffing

Each pool contracts with the Association for program administration services. There are currently 14 insurance staff members involved in the day-to-day administration, all of whom are employed by the Association and managed by the Director of Insurance. The Director serves as a member of the Association's management team and reports to the KACo Executive Director.


Both programs contract with 3rd parties for claims adjusting, actuarial and reinsurance brokerage services as well as four regional marketing agents. All services are monitored and directed by KACo staff.

#### Membership

KACo Insurance funds serve approximately 900 members across the Commonwealth of Kentucky, including 115 of the 120 counties in the state.

#### **Financials**

Current assets on hand include cash and investments totaling approximately \$300 million. We collect approximately \$90 million in annual member contributions and insure over \$9 billion in total property value.

#### **ABOUT THE POSITION**

The Director has primary responsibility for making recommendations to the Executive Management Team and the Board of Trustees for the respective funds for the long-term strategic direction of the programs and the day-to-day management of the insurance operations and staff involved in the implementation of program policies and goals regarding program structure, marketing, financial management and contract management and negotiation. In addition, the Director collaborates with members of the Executive Management Team regarding member engagement, education and lobbying efforts and serves as a trusted advisor to the insurance Boards of Trustees.

#### **PRIMARY RESPONSIBILITIES**

- Oversee and direct the KACo insurance program operations including evaluation of program structure, reinsurance coverage, staffing needs, policy coverages, pricing models and member service programs as well as making recommendations to the Executive Management Team and the Boards of Directors.
- Serve as a primary ambassador of the insurance programs with the membership, affiliated organizations, the insurance industry and other outside stakeholders.
- Direct and manage the work of the insurance underwriting, claims, loss control and customer service staff and make recommendations to the KACo Executive Director regarding personnel matters.

- Serve as the primary point of contact for various contracted service providers, including but not limited to, reinsurance carriers, reinsurance brokers, third-party claims administrators, actuaries and regional agents. Evaluate the nature and extent of services needed, evaluate and negotiate contractual arrangements and make recommendations to the Executive Management Team and Board of Directors.
- Oversee compliance with all regulatory matters involving the funds, including compliance with all federal and state regulatory and auditing requirements and facilitate good working relationships with regulatory agency personnel as appropriate to maintain good coordination and communication in the interest of the funds.

#### Other Responsibilities

- Serving as liaison to the Health Program administrator which markets and manages a fully insured association health program with Anthem that is endorsed by the Association
- Managing a public official bond program underwritten by Liberty Mutual and marketed by KACo
- Attend and present at various member conferences within the state
- Attend out of state meetings and conferences held by industry groups (AGRIP, PRIMA, etc.) and our reinsurer, County Reinsurance Limited

#### REQUIREMENTS

#### **Skills and Knowledge**

- Excellent interpersonal and communication skills.
- Ability to create and maintain positive, collaborative relationships with stakeholders
- In-depth understanding of pooling, insurance and reinsurance operations.
- Highly motivated and self-driven.
- Strong organizational skills with the ability to develop and manage comprehensive strategic initiatives.

#### **EXPERIENCE AND QUALIFICATIONS**

- Ten years of related experience or equivalent combination of education and experience.
- Bachelor's degree and/or insurance education; advanced degree(s) a plus.
- Three years of personnel management experience with a record of success

#### **GEOGRAPHICAL PROXIMITY**

This position is Kentucky based and will operate under a hybrid structure, featuring a combination of in-office and remote work. Attendance at KACo association and insurance board meetings, conferences and educational events, out of state reinsurance board meetings and various in state conferences and events will be required.

The new Director of Insurance brings substantial experience and expertise in insurance, as well as an understanding of local government and insurance pools. Underwriting or actuarial background is a significant plus. The ideal candidate brings a sophisticated set of communication skills and the acumen to navigate relationships and issues with KACo members and elected officials across Kentucky in a dynamic regulatory, legal, and political environment. KACo seeks an insurance professional with the demonstrated ability to lead people in a caring workplace culture where team members are valued and supported professionally and personally, and where there is stable, effective leadership, camaraderie, and opportunity. The ideal candidate will be a solution driven member of the KACo management team, able to collaboratively drive organizational goals and objectives to assure KACo's financial and operational success.
